Decision of Industrial Land Management Advisory Committee(ILMAC):

107

This case was taken-up by ILMAC for change of constitution of **Plot No.22/Pkt-E/Sec.-1/250sq.mtrs./Bawana**. Initially, there were two partners, Sh. Suresh Kumar Gupta (O1) & Smt. Veena Gupta (O2). One of the partners, Smt. Veena Gupta (O2) retired on 01.01.2007 (C/158-160). Thereafter, the continuing partner had requested for COC in his favour as proprietor of the firm on the basis of documents submitted by him, such as, Dissolution Deed, Regd. Indemnity Bond, Form-'C', Amended STRC, Affidavit/NOC etc. Later as per the opinion of L.C. that Regd. Release Deed can suffice the requirement of LMG for the purpose of allowing COC relating to retirement of the partner in lieu of Regd. Gift/Conveyance Deed after the payment of UEI charges. Accordingly, the applicant has submitted a Regd. Release Deed (C/216-220) after paying the stamp duty of Rs. 3,45,000/-. UEI charges of ₹ 8,19,525/- in this case is leviable.

In view of above, ILMAC recommends deletion of name of Smt. Veena Gupta due to retirement from the said firm and allow the continuing partner Sh. Suresh Kumar Gupta as proprietor of the said firm with payment of UEI charges, subject to clearance of further dues, if any.

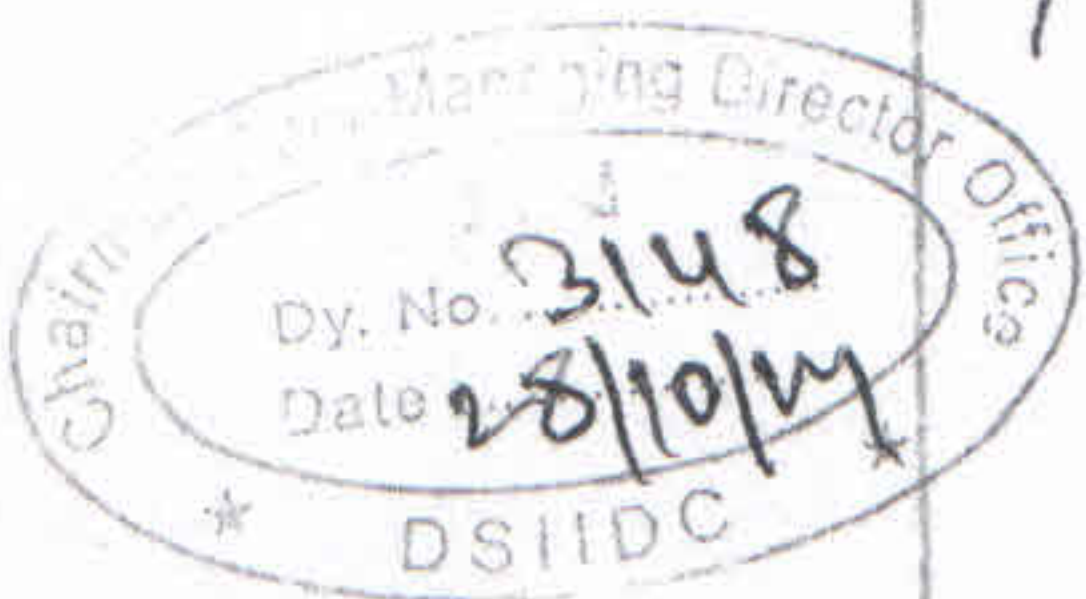

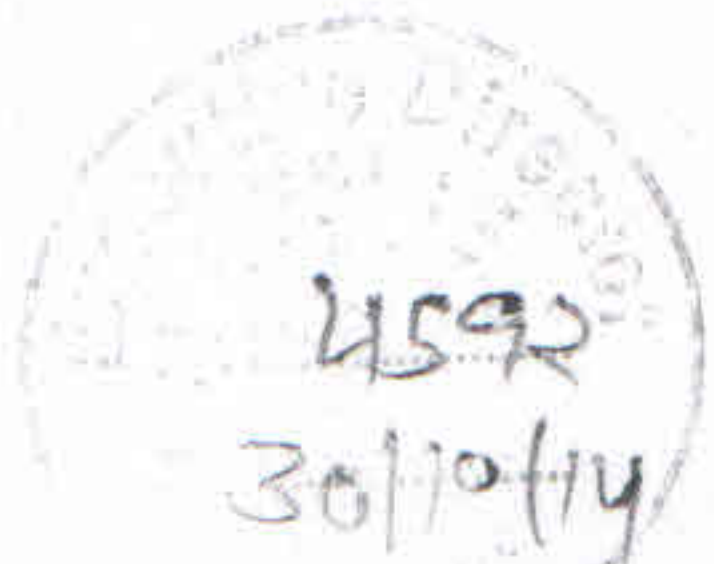
